## Traffic Information for Area Roads

---

**Chipley** – Drivers are reminded to practice caution while traveling in and around work zones in Northwest Florida.

### Bay County:

- Construction activities begin the week of August 7, on improvements to **U.S. 98 from the Dupont Bridge to the Gulf County line**. The \$8.9M construction contract calls for resurfacing, safety improvements to increase traffic and pedestrian mobility, widening turn lanes at various locations, adding keyhole bike lanes, upgrading pedestrian signals at Sabre Drive on Tyndall AFB, extending the eastbound right turn lane to School Road at Tyndall Elementary, new signage and pavement markings.
- **State Road (S.R.) 30 (U.S. 98) at S.R. 368 (23rd Street) 23rd Street Flyover** – Bridge and MSE wall construction continues west of Seaport Drive and east of 23rd Street in preparation for MSE wall and bridge construction. Traffic control signs and variable message boards are on site to direct traffic through the work zone. Remain alert and watch for temporary lane closures and workers in the area.
- Intersection improvements are complete on **U.S. 98 at S.R. 79** in Panama City Beach.
- The **Arthur Drive Bridge over Lynn Haven Bayou** is taking shape as approach slab and barrier wall work is currently taking place. The bridge remains closed, motorists are using Maryland Avenue, West 14th Street, Connecticut Avenue and Arthur Drive as a detour route.
- Alternating lane closures will take place on S.R. 390 over Mill Bayou as workers perform bridge maintenance work, Monday, July 24 from 8 p.m. to 5 a.m.
- **Public Hearing:** The Florida Department of Transportation (FDOT) will host a public hearing concerning modifications to the median opening at S.R. 30A (U.S. 98/Panama City Beach Parkway) and Fairway Boulevard, Tuesday Aug. 8 from 6 p.m. to 7 p.m. CDT at the Northstar Church, 11901 Panama City Beach Parkway, Panama City Beach. The intent of this project is to only allow for eastbound and westbound left turning movements to increase safety at the intersection.

### Jackson County:

- **I-10 from east of S.R. 71 to east of County Road 69A** – Workers are continuing construction improvements along the corridor and ramp paving at Mile Marker 152. Watch for night time lane closures from 8 p.m. to 6 a.m. Monday through Friday.

All planned construction activities are weather dependent and may be rescheduled in the event of inclement weather. Drivers are reminded to pay attention to the reduced speed limit when traveling through the construction area. For more information, follow the Florida Department of
