Pursuant to the City's Charter, Section 2.04 – Qualifications for Elected Office, the following are required to submit an application for the vacancy:

- Applicants must be a registered voter (elector) of Bay County.
- Applicants must have resided for at least thirty-six (36) months, immediately prior to the appointment, within the city limits of the City of Callaway, Florida and at least six (6) months immediately prior to the day of the election within the ward for which they are candidates.

Submission of a Résumé is welcome and encouraged. Following appointment, applicant will be required to file a Financial Disclosure.
