Fowl Permit

This permit allows for the fowl on the following property:

Per City of Callaway Code of Ordinances:

Sec. 4-8. Keeping livestock or fowl.

- a. The term "livestock" as used in this section shall mean cattle, hogs, goats, horses, mules, sheep and other domesticated barnyard animals. The term "fowl" as used in this section shall mean chickens, geese, ducks, turkeys, and other domesticated barnyard fowl.
- b. It shall be unlawful to keep any fowl within the city limits without first obtaining the written permission of the owners or occupants of all property abutting the premises on which such fowl are to be kept and without further obtaining the written permission of the city clerk or his designee.
- c. Any livestock or fowl kept within the city limits without the permission or permit required by subsection (b) or (c) shall be subject to impoundment.
- d. In the event that anyone shall procure permission to keep fowl within the city limits or shall otherwise obtain a permit for the keeping of other animals, such fowl or animals shall be kept in a pen, yard or place which shall comply with sanitary conditions required by the state department of health, or the county health unit.

This permit may be revoked by the City of Callaway with or without cause. At no time shall permit holder allow the fowl to:

- a. Run at large
- b. Produce noise
- c. Become unsanitary
- d. Produce obnoxious odors and stench

This permit is not transferable. In the event this permit is revoked, the permit holder & property owner will receive a Notice of Violation.

PETITION TO KEEP FOWL

I, _____ of _____ wish to apply for a permit from the City of Callaway to keep fowl, namely, _____, on my property.

It is unlawful to keep any fowl within the city limits without first obtaining the written permission of the owners or occupants of all property abutting the premises on which such fowl are to be kept.

Therefore, I ask for your written permission to keep fowl on my property and hereby agree to adhere to the Code of the City of Callaway regarding fowl as follows:

1. In the event that anyone shall procure permission to keep fowl within the city limits or shall otherwise obtain a permit for the keeping of other animals, such fowl or animals shall be kept in a pen, yard or place which shall comply with sanitary conditions required by the state department of health, or the county health unit.
2. The permit, if approved, may be revoked by the City of Callaway with or without cause.
3. At no time will the fowl be allowed to:
 - a. Run at large
 - b. Produce noise
 - c. Become unsanitary
 - d. Produce obnoxious odors and stenches
4. **The permit will not be transferable.**
